REFUND POLICY

1. A cooling-off period of ten (10) working days applies.
2. Application fee is non-refundable beyond the cooling-off period.
3. If a student withdraws by written notice, at any time prior to the Census date, no FEE HELP debt will be incurred by the student.
4. If a student withdraws by written notice, at any time after the Census date, the student will incur the FEE HELP debt for the unit(s) of study.
5. If the course is cancelled by VIT prior to the Census date, the student will not incur any FEE HELP debt for those unit(s) of study.
